PERSONAL DATA PRIVACY POLICY ACCORDING TO ARTICLE 13 OF EU REGULATION 2016/679

In compliance with the European Regulation on the Protection of Personal Data 2016/679, we are providing you with the necessary information regarding the processing of the personal data you have provided. This is a privacy policy provided according to Article 13 of European Regulation 2016/679 (hereinafter “GDPR”).

THE DATA CONTROLLER

The Data Controller is **Crippa Campeggio S.r.l.** (hereinafter the “Company”) in the person of its *pro tempore* legal representative and with registered office at Via del Dosso, 9 – 20841 Carate Brianza (MB), which can be contacted at the following e-mail address: privacy@crippacampeggio.com

PURPOSE OF THE PROCESSING, LEGAL BASIS AND STORAGE TIMES

The personal data will be collected and processed for the following purposes:

- (a) **Purposes related to the establishment and execution of the contractual relationship between the supplier and the Company:** the legal basis is the execution of the contract (Article 6.1, letter b of the GDPR);
- (b) **Carrying out administrative and accounting obligations:** the legal basis is the need to fulfil a legal obligation to which the Company is subject (Article 6.1 letter c of the GDPR);
- (c) **If necessary, to ascertain, exercise and/or defend the rights of the Company in court;** the legal basis is the legitimate interest of the Data Controller (Article 6.1 letter f of the GDPR).

For the purposes indicated in points (a) and (b), personal data will be held for the contractual duration and, after termination, for ten years; for the purposes referred to in point (c), personal data will be kept for the entire duration of the dispute, up until the jurisdictional time limit for an appeal.

PROCESSING METHODS

Data will be processed in an automated and manual form, through the use of tools and procedures suitable for guaranteeing maximum security and confidentiality, by persons specifically authorised to do so and protected from unauthorised access, in compliance with the provisions of Article 32 of the GDPR.

CATEGORIES OF SUBJECTS TO WHOM THE DATA MAY BE COMMUNICATED

For the pursuit of the purposes above, **Crippa Campeggio S.r.l.** will not disclose your personal data; however, the Company may need to communicate your personal data to third parties to fulfil legal obligations or carry out activities that are instrumental to the provision of the requested services. These subjects belong to the following categories:

- (a) Public authorities and supervisory and control bodies when required by specific legislative, regulatory and authorisation provisions;
- (b) subjects who perform tasks of a technical or organisational nature on behalf of the Company; subjects who carry out archiving and data entry activities;
- (c) subjects who carry out accounting, tax and insurance obligations, mailing, subjects who collect and make payments on behalf of the Data Controller.

The subjects belonging to the above categories process personal data as independent Data Controllers or as external Data Processors appointed explicitly by **Crippa Campeggio S.r.l.**

The list of External Data Processors is available to the data subject, who explicitly requests it from the Data Controller's registered office.

Lastly, all employees who carry out their activities based on instructions received from the Data Controller have been specifically authorized by the same. The Data Controller has given these subjects adequate operating instructions regarding the adoption of minimum security measures to guarantee confidentiality and security of the data.

THE DATA SUBJECT'S RIGHTS

Finally, we inform you that at any time you can exercise the rights provided for in Articles 15 and following of the GDPR. In particular:

- obtain confirmation of the existence of personal data concerning you, even if not yet registered and dissemination in intelligent form of the same data as well as their origin, purpose, processing methods and the logic applied in case of processing performed with electronic instruments;
- obtain the cancellation, transformation into anonymous form or block the data processed that does not require storage for the purposes for which it was collected and processed;
- update, correct, and integrate the data processed;
- oppose , in whole or part, for legitimate reasons, the processing of personal data even relevant to the purpose of the collection;
- oppose , in whole or part, for legitimate reasons, the processing of personal data even relevant to the purpose of the collection;
- lodge a complaint with the Supervisory Authorities;
