

PRIVACY NOTICE REGARDING THE PROCESSING OF PERSONAL DATA CONNECTED TO THE CONTACT REQUEST AND NEWSLETTER SERVICE OF CRIPPACAMPEGGIO

This Privacy Notice is provided pursuant to Article 13 of the European Regulation on the protection of personal data 2016/679, known as GDPR (General Data Protection Regulation), and Legislative Decree 30 June 2003, no. 196, known as the Privacy Code (as amended by Legislative Decree 10 August 2018, no. 101), with the aim of providing information about the purposes and methods of processing of personal data, any recipients of such data, as well as the rights granted to data subjects.

DATA CONTROLLER

The data controller is “Crippacampeggio S.r.l. a Socio unico” (*hereinafter, ‘Crippacampeggio’*) with registered office at Corzo Europa 12, 20122 Milano (MI), Italy. It can be contacted at the following email address: privacy@crippacampeggio.it.

TYPES OF PERSONAL DATA, PURPOSES, AND LEGAL BASIS OF THE PROCESSING

The processing concerns the following data:

- 1) **Personal data:** name, surname, email address, VAT number, type of user.

You are informed that your data listed under point (1):

a) **are processed in order to contact you and provide the information you requested** through the dedicated form you completed. The legal basis for this processing is the **performance of a contract to which the data subject is party or the execution of pre-contractual measures adopted at the data subject’s request**, pursuant to Article 6(1)(b) of EU Regulation 2016/679 (GDPR).

b) **are processed to send you advertising, informational, promotional materials and periodic updates** regarding initiatives, products, and events of Crippacampeggio (newsletter).

The legal basis for this processing is the **data subject’s consent**, pursuant to Article 6(1)(a) of EU Regulation 2016/679 (GDPR).

METHODS OF PROCESSING

The processing of personal data will be carried out using electronic or automated means, in compliance with the principles of necessity and data minimisation, and only for the time strictly necessary to achieve the stated purposes.

The Data Controller adopts appropriate technical and organisational measures to ensure a level of security appropriate to the type of data processed (Article 32 of EU Regulation 679/2016).

NATURE OF DATA PROVISION AND CONSEQUENCES OF FAILURE TO PROVIDE DATA

Providing personal data for the purpose referred to in letter (a) is **mandatory**. Refusal to provide such data will prevent the data subject from using the services/content offered by the Crippacampeggio website.

Providing personal data for the purpose referred to in letter (b) is **optional**. Refusal to provide such data will prevent the sending of the newsletter to those who explicitly requested it.

UNSUBSCRIBING FROM THE NEWSLETTER

To stop receiving the newsletter, the user may click on the “Unsubscribe” button at the bottom of each communication and confirm the unsubscription on the page that opens by clicking “Confirm.”

DISCLOSURE AND DISSEMINATION OF PERSONAL DATA

Your data will be processed exclusively by the data controller and by specifically trained personnel authorised to process and protect the data. Personal data will never be disclosed to third parties except where required by law. Data will not be disseminated. The data controller does not transfer personal data to third countries outside the EU.

AUTOMATED PROCESSES AND PROFILING

The personal data provided are **not** subject to any fully automated decision-making process, including profiling, that may produce legal effects concerning you or significantly affect you.

Your personal data collected for the purposes under letter (b) will be retained **until the withdrawal of consent** by the data subject for the mentioned purpose.

DATA SUBJECT RIGHTS

Pursuant to Articles 15–22 of the GDPR, you may exercise the following rights:

- **Right of access**, including obtaining information on: processing purposes and methods; categories of personal data; recipients or categories of recipients; retention period; logic applied in case of automated processing; identification details of the controller and processors;
- **Right to rectification or integration** of data;
- **Right to erasure** (in the cases provided by the Regulation), anonymisation, or restriction of processing of data processed unlawfully, without prejudice to legal obligations for retention;
- **Right to data portability**;
- **Right to object**, on legitimate grounds, to the processing of data.

You also have the right to lodge a complaint with a Supervisory Authority.
