

## PRIVACY NOTICE FOR SUPPLIERS PURSUANT TO ARTICLE 13 OF EU REGULATION 2016/679

In compliance with European Regulation 2016/679 on the Protection of Personal Data, we provide you with the necessary information regarding the processing of the personal data you have supplied. This notice is also provided pursuant to Article 13 of the Regulation (EU) 2016/679 (“GDPR”).

### DATA CONTROLLER

The Data Controller is “Crippacampeggio S.r.l. a Socio Unico” (the “Company” or “Crippacampeggio”), in the person of its legal representative *pro tempore*, with registered office at **Corso Europa 12, 20122 Milano (MI)** which may be contacted at: [privacy@crippacampeggio.it](mailto:privacy@crippacampeggio.it).

### PURPOSES OF PROCESSING, LEGAL BASIS AND RETENTION PERIOD

Personal data are collected and processed for the following purposes:

- (a) Purposes related to the establishment and performance of the contractual relationship between the supplier and the Company; the legal basis is the performance of a contract (Art. 6(1)(b) GDPR);
- (b) Fulfilment of administrative and accounting obligations; the legal basis is compliance with a legal obligation to which the Company is subject (Art. 6(1)(c) GDPR);
- (c) Where necessary, for the establishment, exercise or defence of the Company’s rights in judicial proceedings; the legal basis is the Controller’s legitimate interest (Art. 6(1)(f) GDPR).

For the purposes referred to in points (a) and (b), personal data will be retained for the duration of the contractual relationship and, after its termination, for ten years. For the purpose referred to in point (c), personal data will be retained for the entire duration of the legal proceedings until the expiry of all time limits for lodging appeals.

### METHODS OF PROCESSING

Your personal data will be processed both manually and through automated means, using instruments and procedures suitable to ensure the highest level of security and confidentiality. Processing is carried out by authorised personnel, protected against unauthorised access, in accordance with Article 32 GDPR.

### Categories of entities to whom the data may be communicated



For the purposes described above, Crippacampeggio will not disclose your personal data; however, the Company may need to communicate your personal data to third parties in order to comply with legal obligations or to carry out activities instrumental to the provision of the requested services. These recipients fall into the following categories:

- (a) public authorities and supervisory or regulatory bodies, where required by specific legal, regulatory, or authorisation provisions;
- (b) entities performing technical or organisational tasks on behalf of the Company; entities providing archiving or data-entry services;
- (c) entities performing accounting, tax and insurance-related activities, mailing services, or the management of payments and collections on behalf of the Data Controller.

The entities belonging to the above categories process personal data as Independent Data Controllers or as external Data Processors duly appointed by Crippacampeggio.

The list of external Data Processors is available to the data subject upon explicit request at the registered office of the Data Controller.

Finally, all employees acting on the basis of instructions issued by the Data Controller have been duly authorised and trained. The Data Controller provides appropriate operational instructions, particularly regarding the adoption of minimum security measures, in order to ensure the confidentiality and security of the data.

## DATA SUBJECT RIGHTS

We also inform you that, at any time, you may exercise the rights provided for in Articles 15 et seq. of the GDPR. In particular, you may:

- obtain confirmation of the existence of personal data concerning you, even if not yet recorded, and receive communication of such data in an intelligible form, including their origin, as well as the purposes and methods of the processing and the logic applied in the event of processing carried out by electronic means;
- obtain the erasure, anonymisation or restriction of data whose retention is unnecessary in relation to the purposes for which they were collected or processed;
- obtain the updating, rectification and integration of the data;
- object, in whole or in part, on legitimate grounds, to the processing of personal data concerning you, even if relevant to the purpose of the collection;
- lodge a complaint with the Supervisory Authorities.
